From Scheme of Delegation:

Size of LSB – The number and nature of LSB governors must ensure there are enough to carry out the duties of the LSB as identified in this Scheme of Delegation which will be kept under review. To that end there should be a maximum of 8 governors including 2 elected parent governors and 2 elected staff governors. LSB governors must be approved by the Trustee Board. There must be a balance between external governors and those who have children at the school.
